Date: 2/2/2016, 7:09 PM The meeting of the Prop Busters was called to order by Charles Strang, at IHOP, 14424 San Pedro Ave, just north of Bitters on 281.

Visitors: None

The January meeting minutes were approved without revision.

President: Charles welcomed everyone.

Vice President/Safety Officer: Dress for the cold (if and when it ever gets cold) and check the runway for gopher holes. Watch out for snakes.

Secretary: Terry no comment.

Treasurer: Jim reported the various expenses, income, and account balances for January and recapped the budget and balances. He commented that expenses for potential events will be discussed later. If you need details contact Jim.

Early Bird Raffle: Dave Gell, Fuel

Membership: Rick reported two new applications. Richard Litton sent in his application with payment. Richard is a past member from a few decades ago and has been known to fly "drones "on his property down south. He also has a legacy of making a "smoking hole" in the old Bandera Road field. Richard's membership was approved by all. The other application was sent in by Zachary Rice without payment and will be voted on after payment is received.

Newsletter: Standing order for the newsletter is that free ads and articles of interest for the newsletter need to be submitted by members to **John Gardner** by the 17th.

Web Editor

Robert Jarzombek has updated the website to include changes to Flying Rules and Regulations approved during this meeting.

Old Business:

Hobby Shop Flyer: The one page flyer was worked over by the EC more than once and was offered for approval by those present at the meeting. After circulating the flyer, the document was approved. Thanks to John Gardner and Robert Jarzombek for keeping the ball rolling. Forty copies will be printed and distributed to the hobby shops.

Flying Regulations: The flying regulations, as distributed in the January newsletter, were read at the meeting. The motion to accept the revisions without edit was approved by all present.

Rumor Has It: Jim Branaum mentioned that there was a rumor at the field that "Helicopter were Outlawed" by the club. There is no truth to the rumor. He reminded all that changes to the club flying regulations are always printed in the Newsletter for discussion at the meeting following that newsletter distribution, and prior to any vote to accept or reject any changes. No such action as rumored above was considered or even discussed.

FAA Registration of RC Aircraft: As given in the updated flying regulations, all aircraft flown at our

fields are to have FAA registration and the pilot must have his registration card on his person, which also has FAA rules for flight operations.

New Business:

Events: Should we have sanctioned events or simply have club events? It was noted that at least two AMA sanctioned events are required to maintain registration of our Contest Director, Bob Severance. Sanctioned **Events** have the benefit of advertisement by AMA, but also ensure that the event doesn't conflict with other area AMA sanctioned events. **Club Events** are primarily for the benefit of only club members. Both generally have landing fees to offset expenses and serve to encourage camaraderie while bringing together people with a common interest in RC modeling.

From general discussion, it was accepted that Club Events would include; July 4th, Labor Day, and the New Years Day Pea Feed.
For a first Sanctioned Event, it was decided that a May Fun-Fly would be held on May 21, with the rain day back-up of May 30 (Memorial Day).

Gorge Wilson suggested having a sanctioned event that encouraged building models rather than assembling models. He proposed having a "Model Builders Event". The event would only allow models constructed from kits, plans, or from your imagination. ARFs, BNF/RTF would not be allowed. The one day event would be open to all AMA members and follow AMA and FAA rules. He proposed there would be at least one plaque for "Pilots Choice" but more could be added. He

suggested that a raffle of various items would use ONLY tickets obtained as: one for each plane entered and one for each flight (not just touch and goes).

Discussion added that perhaps crashes may be considered for a ticket, maybe two tickets for a smoking hole! The idea was discussed and it was accepted that Model Builders Event should be placed in the Fall to give time for those who are interested to build a plane if they didn't already have an entry. The date for this second sanctioned event will be decided at the March meeting.

MODEL OF THE MONTH:

George Wilson showed his laser cut kit build of his Sig Cadet LT 45. He indicated he built it to refresh his covering skills. He noted that you have to sand of the laser burn edges to prevent the black char from showing through light colored covering like the yellow covering he used. He carefully glued the airframe together, commenting that excess glue only adds weight not strength. With a 60 inch wing span and a long tail moment, the plane should fly well with the OS 25.

Charles Strang described his Versa Copter built from a \$59 Flight Test kit because he was interested in quad copters. He added a video camera using brackets made on his 3D printer. Later he added a FPV (first person view) using a screen, but then transitioned to FPV goggles for an expanded experience. He commented that the FVP can be disorienting. You see only what the camera sees, so you can easily lose situational awareness of where you

(as AMA requires for safe operation during FPV pilots).

NO NEED TO CLOSE THE HIGHWAY GATE unless you are the last to leave! Run the lock through Only the End Most links of the chain.

If you need to get to the fly over area, do not climb over the electric fence as that puts strain on the wire. USE THE HOT GATE IN THE MIDDLE OF THE FENCE.

Grasp only the plastic handle on the Top wire, unhook that line and hang it on the hook of the corresponding T post to the right. Do the same for the Middle and Bottom wires. Reverse to close the HOT GATE. Be careful not to get shocked! If in doubt, get HELP

San Antonio Prop Busters FLYING REGULATIONS

Revised February 2016

I. Use of Flying Field

- AMA License. All flyers must hold current AMA licenses and present this license or equivalent
- В. Membership. All flyers must be a member of SAPB or an invited guest of a member.
- Identification. All members are urged to wear their name tags at the flying field.

D. vote of the membership. D. <u>Guesis (Local)</u>. A local guest of a SAPB member may use the flying field two (2) times after which the guest must apply for membership. Special circumstances may result in exceptions to this rule if approved by a

- Guests (General). A SAPB member may only host one (1) flying guest each day
- Transient use. Transient personnel who have paid any fees required in the by-laws may fly at the field.
- G. will operate within the FAA Rules and Regulations, as applicable to Unmanned Aerial Systems (UAS). All flyers. Operating Radio Controlled Model Aircraft of any type (fixed wing, rotary wing, or multi-rotor)

II. Field Safety Rules.

- Spectator and ground traffic control.
- Spectators and all pets are restricted to the designated spectator areas
- Automobiles will be restricted to the designated roadway and parking areas.
- Taxing allowed only on the designated taxiways from the Pits to the runway

- AMA and FAA safety regulations apply to all activities
- Front of pilot stations beyond the flight line, Take-offs or Hand Launches permitted only from the designated Grass, Paved, or Water runways in
- Aircraft noise abatement and safety
- No flow-thru or stack type mufflers are permitted on 2-stroke engines. Mufflers are mandatory on all 2 stroke engines. This muffler must be of the closed chamber type only

Note: This rule does not include .049 and smaller engines that do not come with mufflers

- Four stroke engines must use factory or equivalent mufflers, if supplied
- D.
- GHZ Radios (2.4 GHZ transmitters do not require Frequency Tags.) The transmitter's channel ID will be displayed on the transmitter antenna with the exception of 2.4
- transmitter impound area. Use of the transmitter impound area is mandatory. Recommended procedures shall be posted in the
- frequency spacing or 2.4 GHZ Radios (Spread Spectrum Technology) the Radio Control equipment specifications detailed in the Academy Guidelines for operation at 20 kHz All transmitters and receivers used at SAPB facilities must be narrow band units meeting or exceeding

Flying areas and procedures.

- No flying over pit areas or spectators will be permitted
- stand a minimum of twenty five (25) feet back from the edge of the runway The approved flying area is on the side of the runway away from the spectator areas. Flyers are to
- Control line aircraft will be flown in the designated area

Pit areas.

- No engine running will be allowed under the pavilion area or outside of the pit or flying areas.
- Engine testing and break-in is allowed only in the designated area

Use or discharge of firearms and the like at the flying field is prohibited

A. General

III. Provisions for Enforcement

Any three (3) open card club members will have the authority to temporarily ground an individual if they believe that his or her aircraft, equipment, or flight are not in accordance with safety standards. Such grounding order will be given to the individual in question, in wiring, clearly stating the reasons for such action and signed by each of the three enforcing members. It is the responsibility of each member to support safety

Penalties.

- no proof of AMA licenses. flying day. They can do so on the basis of equipment condition, repeated violation of flying procedures, or Any three (3) AMA open card club members can ground any individual for the remainder of the
- (2/3) vote of the members present. A flyer can be grounded for one month by a unanimous vote of the executive committee or two thirds
- A flyer can be grounded for periods longer than one month or voted out of the club for repeated serious violations, in accordance with provisions of the by-laws.
